

2010 Senate Votes

Vote 1: Final Passage of H.R. 4872, the "Health Care and Education Affordability Reconciliation Act"; March 24, 2010 (Passed, 56-43); Roll Call #105; Christian Coalition of America did not support.

Vote 2: Coburn Amendment 3556 to H.R. 4872, the "Health Care and Education Affordability Reconciliation Act"; ("Viagra amendment for child molesters/rapists"). March 24, 2010. (Failed, 57-42, needed 60 votes to pass) Roll Call #73. The Coburn amendment would have reduced health care costs by preventing fraudulent payments for prescription drugs, prohibiting coverage of erectile dysfunction drugs to child molesters and rapists, and excluding coverage of abortion drugs; This amendment would save taxpayers tens of millions of dollars a year by preventing payments for fraudulent prescriptions by Medicaid and prohibiting coverage of unnecessary drugs in the new health care exchanges. Christian Coalition of America opposed the parliamentary scheme to "table the Coburn amendment."

Vote 3: Final Passage of Omnibus Appropriations bill, December 13, 2009 (57-35); Roll Call #374; Bill includes funding for abortions in the nation's capital; bill lifts the 13-year-long ban on directly paying for abortions in the nation's capital. It also contains funding for the abortion groups, Planned Parenthood and the UNFPA. (Republicans Richard Shelby, Thad Cochran, and Susan Collins voted for the bill.) Christian Coalition of America did not support.

Vote 4: Passage of President Barack Obama's first budget, S. Con. Res. 13 (as amended); April 2, 2009, (55-43); Roll Call #154. Obama's budget will cost the American people \$3.6 trillion. Christian Coalition of America did not support.

Vote 5: Robert Bennett Amendment 3568 to H.R. 4872, the "Health Care and Education Affordability Reconciliation Act"; March 25, 2020. (amendment failed 36-59) Roll Call #89. Amendment would have effectively allowed citizens of

the District of Columbia to ban homosexual "marriage". Christian Coalition of America supported.

Vote 6: Huchison Amendment 3635 to H.R. 4872, the "Health Care and Education Affordability Reconciliation Act"; March 25, 2020. (amendment failed 40-55) Roll Call #91. Amendment would have continued relief from marriage penalty taxes, among other provisions. Christian Coalition of America supported.

Vote 7: Ensign Amendment 3710 to H.R. 4872, the "Health Care and Education Affordability Reconciliation Act"; March 25, 2020. (Motion to table amendment passed 58-40) Roll Call #101. The Senate voted to table the Amendment which would have gotten rid of the penalty for failure to comply with the unconstitutional individual health care mandate. Christian Coalition of America supported a No vote to table the amendment.

Vote 8: Vitter amendment to the FY10 Commerce/Justice/State Appropriations Bill, H.R. 2847, October 7, 2009 (61-38), Roll Call #316: The Senate voted to table the Amendment would have banned the use of federal COPS funds for sanctuary cities not obeying the federal law with regards to illegal aliens. Christian Coalition of America supported a No vote to table the amendment.

Vote 9: Coburn amendment #828 to S. Con Res. 13; April 2, 2009, (41-56), Roll Call #152: Amendment would protect the freedom of conscience for patients and the right of health care providers to serve patients without violating their moral and religious convictions. Christian Coalition of America supported the amendment.

Vote 10: DeMint amendment, #189, to H.R. 1; February 5, 2009 (43-54); Roll Call #47: Amendment would allow the free exercise of religion at institutions of higher education that receive federal funding. Christian Coalition of America supported this amendment.

2010 House Votes

Vote 1: Passage of "Affordable Health Care for America Act," H R 3962; November 7, 2009, (220-215), Roll Call #887; This bill was the original version of Obamacare in the House of Representatives. A vote for this bill is a negative vote. Christian Coalition of America did not support.

Vote 2: Stupak amendment preventing taxpayer-payer funding for abortions, November 7, 2009 (240-194), Roll Call #884; A vote for the Stupak amendment is a positive vote. Christian Coalition of America supported.

Vote 3: Passage of the "Patient Protection and Affordable Care Act" (concur with the Senate bill); March 21, 2010 (219-212); Roll Call #165; Christian Coalition of America did not support. A vote for this bill is a negative vote.

Vote 4: Passage of the "Reconciliation Act of 2010" [to amend the Senate bill with the House bill's Stupak amendment with regards to abortion]; March 21, 2010 (199-232); Roll Call #166; Boehner motion to recommit so that the Stupak pro-life provisions could be restored to the final version of Obamacare. Christian Coalition of America supported the Boehner motion to recommit. A vote for the Boehner motion to recommit is a positive vote.

Vote 5: Passage of the "Reconciliation Act of 2010" [requested "fixes" of Senate bill]; March 21, 2010 (220-211); Roll Call #167; Christian Coalition of America did not support. A vote for this bill is a negative vote.

Vote 6: Passage of the "Local Law Enforcement Hate Crimes Prevention Act of 2009"; H.R. 1913; April 29, 2009, (249-175.) Roll Call #223; Bill gives special rights to homosexuals including "perceived sexual orientation." Many Republicans, as well as some Democrats, argue that the legislation would turn law enforcement into thought police, forcing them to determine what a person was thinking while he or she committed a crime. Moreover, it would protect some victims over others and would federal-

ize crimes that the states are already handling on their own. A vote for this bill is a negative vote. Christian Coalition of America did not support.

Vote 7: Passage of the Murphy amendment to the 2011 Defense Authorization bill which would abolish the 1993 law banning open homosexuals in the military; May 27, 2010 (234-194); Roll Call #317; Christian Coalition of America opposed this amendment. A vote for the Murphy amendment is a negative vote.

Vote 8: Passage of the unconstitutional "DISCLOSE Act," H.R. 5175, to censor certain groups, many of which are not in favor with the Democrats controlling the 111th Congress, i.e. unions were exempted from campaign finance reporting requirements; June 24, 2010 (219-206); Roll Call #391; Christian Coalition of America opposed this legislation. A vote for the "DISCLOSE Act" is a negative vote.

Vote 9: A "motion to instruct" (MTR) amendment to the unconstitutional "DISCLOSE Act," H.R. 5175; this anti-First Amendment bill would censor certain groups in America; the MTR amendment would prohibit lobbyists from state sponsors of terrorism, i.e. Cuba, Iran, Sudan, and Syria; prohibit campaign funds for political robo-calls made to individuals on the do-not-call registry; would provide for an expedited judicial review process in the event that a constitutional challenge is brought against the bill; June 24, 2010 (208-217); Roll Call #390; Christian Coalition of America supported this MTR amendment. A vote for this MTR amendment is a positive vote.

Vote 10: Passage of the Financial Services Appropriations bill, H.R. 3170, which removed the ban of taxpayer-funded abortions in the District of Columbia for the first time in many years; July 16, 2009, (219-208), Roll Call #571; Christian Coalition of America did not support this bill. A vote for this bill is a negative vote.
