

# 2014 Senate Votes

**Vote 1:** No Abortion Funding For United Nations: An amendment that would not allow legislation to proceed in the Senate which provides taxpayer funding to the United Nations while any member nation forces citizens or residents of that nation to undergo involuntary abortions. Defeated 38-61. Roll Call vote 86, March 23, 2013. Christian Coalition supported this amendment.

**Vote 2:** Special rights for homosexuals: A bill to give special rights to homosexuals in the matter of employment. Passed 64-32. Roll Call vote 232, November 7, 2013. Christian Coalition opposed this bill.

**Vote 3:** Repeal ObamaCare: An amendment to repeal ObamaCare and to encourage patient-centered reforms to improve health outcomes and reduce health care costs, promoting economic growth. Defeated 45-54. Roll Call vote 51, March 22, 2013. Christian Coalition supported this amendment.

**Vote 4:** Elimination of Death Tax: An amendment to permanently eliminate the Federal estate tax, the "Death Tax." Defeated 46-53. Roll Call vote 67, March 22, 2013. Christian Coalition supported this amendment.

**Vote 5:** Income tax increases: An amendment to protect Americans from a \$1 Trillion tax increase and provide for pro-growth revenue-neutral comprehensive reform. Defeated 45-54. Roll Call vote 49, March 21, 2013. Christian Coalition supported this amendment.

**Vote 6:** Degradation of Religious Freedom Restoration Act: A bill to undermine the Supreme Court's

"Hobby Lobby vs. Burwell" which allowed certain employers to refuse to pay for and provide abortion-inducing drugs. Passed 56-43. Roll Call vote 228, July 16, 2014. Christian Coalition opposed this bill.

**Vote 7:** Parental Notification on Abortion: An amendment to enact the "Child Interstate Abortion Notification Act." Defeated 48-51. Roll Call vote 64, March 22, 2013. Christian Coalition supported this amendment.

**Vote 8:** Limiting Free Speech Constitutional Amendment: A constitutional amendment allowing the Congress to limit the First Amendment rights of the American people; allowing Congress to regulate election funding. This was a vote to end debate. Defeated 54-42. (60 votes required to end debate.) Roll Call vote 261, September 11, 2014. Christian Coalition opposed this amendment.

**Vote 9:** Appointment of judges who support strict interpretation of the Constitution: A vote to end the debate on the nomination of Pamela Harris to the U.S. Circuit Court of Appeals; a nominee who is clearly against making rulings according to a strict interpretation of the Constitution. Not approved 54-41. (60 votes required to end debate.) Roll Call vote 241, July 24, 2014. Christian Coalition opposed this nomination.

**Vote 10:** Support for 2nd Amendment gun rights: An amendment to protect the Second Amendment gun rights of veterans and their families. Passed 56-44. Roll Call vote 102, April 17, 2013. Christian Coalition supported this amendment.
